

**MINUTES OF A REGULAR MEETING OF THE TOWN BOARD OF TRUSTEES HELD TUESDAY,

**MINUTES**

**PUBLIC HEARING - TAX LEVY**

**2011 TAX LEVY**

It was moved by Trustee Jim Taylor, seconded by Trustee DeTienne that Ordinance 2011-03 be passed, levying taxes in the amount of \$1,585,230 for all town purposes for Zion Township, Lake County, Illinois, for the tax year 2011, collectible in 2012. The vote on roll call was: Trustees Flammini, aye; Shantal Taylor, aye; DeTienne, aye; Jim Taylor, aye; and Chairman Ditzig, aye. Motion carried. Ordinance passed.

**SUPERVISOR'S REPORT**

Supervisor Ditzig stated that the Township assisted 229 seniors with holiday food boxes this year.

Supervisor Ditzig stated that the elf program, which is coordinated through the elementary schools, identifies families in need during the holidays. No Township funds, other than staff time, is spent on this program.
