

MINUTES OF A REGULAR MEETING OF THE TOWN BOARD OF TRUSTEES HELD TUESDAY, OCTOBER 21, 2014 AT 6:30 P.M. IN THE CITY COUNCIL CHAMBERS, CITY HALL, ZION, ILLINOIS

On call of the roll the following answered present: Trustees DeTienne, Hill, Flammini and Taylor. Chairman Neal was absent. Assessor Wicketts was present.

MINUTES
