**ORDINANCE SETTING THE COMPENSATION
OF THE ELECTED OFFICIALS
OF THE TOWNSHIP OF ZION**

WHEREAS, the Town Board of the Township of Zion recognizes the responsibilities of the positions of Township Supervisor, Assessor and Trustees, and

WHEREAS, the Town Board has determined to grant no increase in the compensation of the Township Supervisor, Assessor and Trustees of the Township of Zion.

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIRMAN AND TOWN BOARD OF THE TOWNSHIP OF ZION, COUNTY OF LAKE, STATE OF ILLINOIS:

SECTION I. That the Township Supervisor, who is elected to office in 2017, shall receive the following annual compensation:

May 1, 2017	\$87,383.00
May 1, 2018	\$87,383.00
May 1, 2019	\$87,383.00
May 1, 2020	\$87,383.00

That the Township Assessor, who is elected to office in 2017, shall receive the following annual compensation:

January 1, 2018	\$84,502.00
January 1, 2019	\$84,502.00
January 1, 2020	\$84,502.00
January 1, 2021	\$84,502.00

The Trustees, who are elected to office in 2017 or thereafter, shall receive the following annual compensation:

May 1, 2017	\$1,900.00

The Finance Chairman, who is elected to office in 2017 or thereafter, shall receive the following annual compensation:

May 1, 2017	\$2,300.00

In addition, all elected officials shall be entitled to reimbursement for reasonable and proper expenses incurred on Township business. Elected officials shall also be entitled to participate in the Township dental plan at no cost.

SECTION II. Severability. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in full force and effect.

SECTION III. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Township of Zion prior to the effective date of this ordinance.

SECTION IV. Effective Date: This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form in the manner provided by law.
